General Contractor Ordered to Pay Hacked Subcontractor

According to Statista, a global data and business intelligence platform, data breaches in the United States rose from 447 in 2012 to over 3,200 in 2023. That number is expected to rise each year. Additionally, online fraud costed Americans \$12.5 billion dollars in 2023. Construction companies are not immune to this rise in cyber related crimes. Contracts, change orders, and requests for payment are, for the most part, exchanged via email these days. A general contractor (GC) in Maryland was recently the victim of a hacking/scam in which a hacker purporting to be one of the GCs subcontractors sent the GC a link for an ACH payment. Once the GC sent payment to the hacker the real subcontractor came looking for payment.

The hacker in this case had changed the email address for the subcontractor to a .net email address instead of a .com email address. The receiver did not catch the change in the email address and followed the directives given in the fake email. One interesting aspect of this case is that the fake email contradicted payment directions the real subcontractor previously had sent to the GC. The hacker claimed the subcontractors bank account was "under review" and that the GC needed to send payment via a "Corporate account via ACH only". After some additional email correspondence with the hacker, the GC sent a corporate check to an address provided by the fake subcontractor (which was not the real subcontractor's correct address). The real subcontractor then filed a breach of contract suit against the GC for its failure to pay the true invoice.

The court looked to the parties contract to resolve the payment dispute. The contract was silent as to how the payment should be made. The subcontractor argued it had done the work and the contract requirement payment. The GC argued it in fact made the payment, but for the subcontractor's lax cybersecurity it was not received. In other words, the GC blamed the subcontractor's cybersecurity for the non-payment. The court found in favor of the subcontractor. The court reasoned that the parties could have drafted language regarding cyber-related issues with respect to payments and/or actually put detailed information in their contract as to how payment was to be made.

Hackers are becoming more sophisticated in their attempts to ensnarl businesses in their ploys. Common tactics include changing a capital "O" to a zero "O" in an email address or adding an extra period. Other ways in which hackers are circumnavigating security features is calling a company's IT department asking for "help" resetting passwords and then gaining access to a real individual's email address thus allowing a hacker the ability to pose as a real employee. RE: MIAF CONTRIBUTIONS

MARBA would like to remind all contractors signatory to the collective bargaining agreements MARBA negotiates and administers with the various trades of the obligation to remit industry advancement funds under those CBAs.

The rates for the MARBA Industry Advancement Fund (MIAF) should be remitted at the same time other fringe benefit contributions are made. The process for reporting MIAF contributions differs from trade to trade including the amount to be remitted.

The amounts to be remitted are to be made on a per hour worked basis and are as follows:

Auto Mechanics -- \$0.03

Bricklayers – \$0.13

Carpenters (Cook, Lake, & DuPage) – \$0.09

Carpenters (Kane, Kendall, & McHenry) – \$0.09

Carpenters (Grundy) – \$0.10

Carpenters (Will) - \$0.14

Cement Masons Local 11 – Area 161 – \$0.13

Cement Masons Local 11 – Area 362 – \$0.08

Cement Masons Local 11 – Area 638 – \$0.08

Cement Masons Local 502 - \$0.06

Laborers - \$0.06
