Mid-America Carpenters Regional Council Arbitrations

MARBA received no arbitration demands in the month of June.

Laborers Joint Grievance Committee

The Laborers did not meet in July. The next JGC is set for August 15, 2024, at 9:00 a.m. at the Laborers offices. There are three (3) grievances set to go forward.

Operating Engineers Joint Grievance Committee

The Operating Engineers JGC met on July 10, 2024, at the Operating Engineers office in Countryside. There were initially five (5) grievances to be heard. However, prior to the JGC meeting one was withdrawn, one was continued pending further settlement discussions, and one was paid, leaving two (2) grievances to be heard. The first case involved a contractor that was alleged to have had a non-bargaining unit member run an excavator. The Union presented evidence that the member running the machine was not a union member. The contractor failed to appear. As such the JGC, relying on the evidence and testimony presented by the Union, issued a decision in favor of the Union. The second grievance was continued prior to being heard as the Union received an audit report the morning of the JGC hearing which the Employer did not have the opportunity to review prior to the case being heard. The next JGC hearing will be held on September 11, 2024, beginning at 8:30 a.m. at the Operating Engineers office in Countryside. The number of grievances set to go forward has yet to be determined.

Teamsters Joint Grievance Committee

The Teamsters JGC did not meet in July. The next regularly scheduled JGC is set for August 29, 2024, at the MARBA office, provided there are any grievances set to go forward.

Illinois Department of Labor Post Prevailing Wage Rates

The Illinois Department of Labor has posted the most recent prevailing wage rates on its website as of July 15, 2024. Per the Prevailing Wage Act, the wage rates contained in a CBA will prevail provided 30% of those employed in a locality are covered under said CBA. The rates posted on the IDOL website are continually updated. As such contractors are reminded to check the Department's website for the most current prevailing wage rate in addition to ensuring compliance with the wage rates contained in CBAs. Construction Industry Posts Strong Month for Job Growth

According to the Bureau of Labor Statistics, the construction industry showed strong growth in the month of June, adding 37,000 jobs. The 37,000 jobs outpace the 20,000 per month average monthly gains the industry saw over the previous 12 months. The unemployment rate fell to 3.3% in the construction industry as well. The 3.3% unemployment rate was one of the lowest ever recorded by the BLS further showing just how many more jobs could have been added.

Illinois Joins Handful of Other States Banning Captive Audience Meetings

On Wednesday, July 31, Governor Pritzker signed into law the Illinois Worker Freedom of Speech Act. Illinois becomes one of 18 states to pass or considering passing such legislation. In essence, the Illinois law bans employers from holding mandatory meetings with employees in which company views on religion, unions, and/or unions are shared. These meetings are often referred to as captive audience meetings. Pro-labor organizations hail the signing of the legislation while several groups contend the legislation violates the First Amendment and is in conflict with the National Labor Relations Act.

Under the Act, if an employee is disciplined for refusing to attend one of these meetings they may file a lawsuit against their employer. The new law also allows an "interested party" to file a complaint with the Illinois Department of Labor for alleged violations. Employers may still conduct meetings in which they discuss their views on Unions, but they may not make attendance at such meetings mandatory. The law takes effect on January 1, 2025.
